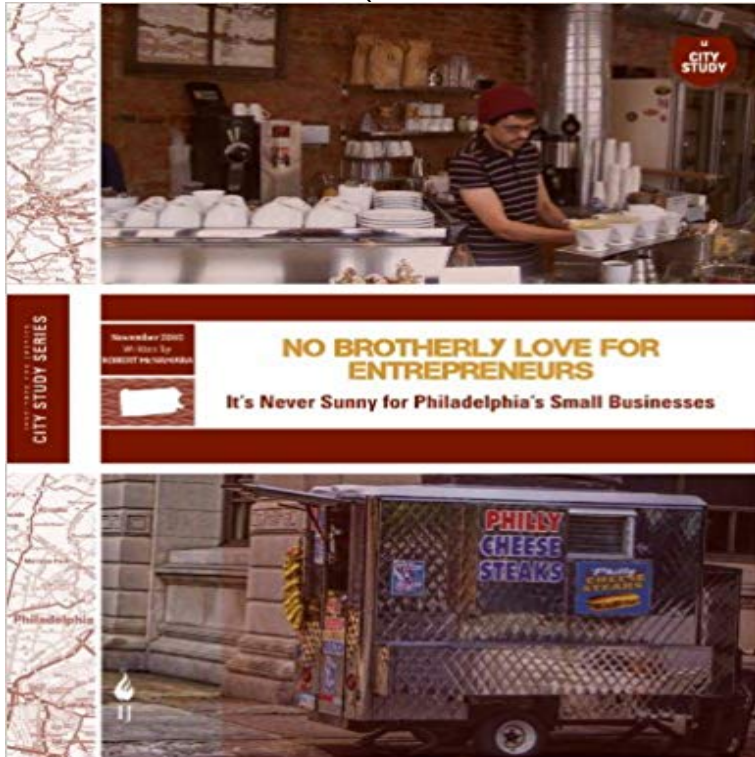


# No Brotherly Love for Entrepreneurs: Its Never Sunny for Philadelphia's Small Businesses (Institute For Justice City Studies)
