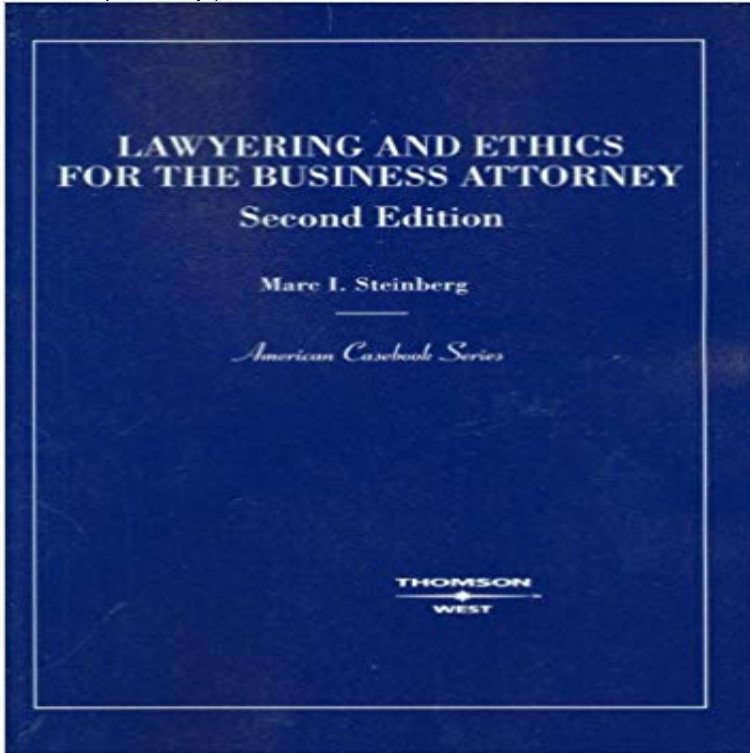


Lawyering and Ethics for the Business Lawyer (American Casebooks)
